

## Privacy Policy

We, at Mega-Fabs Motion Systems Ltd. ("Mega-Fabs") respect your privacy and it is important to us to keep and protect your information collected on our website (the "Website"). This Privacy Policy explains our practices and sets out the basis on which Mega-Fabs treats data it collects, which may be comprised of both "Information", as such term is defined in Israeli Protection of Privacy Law, 5741-1981 (such information shall be referred to as "Personally Identifiable Information" and the aforesaid law shall be referred to as the "PPL") and non-Personally Identifiable Information (the "Non-Personally Identifiable Information"). Personally Identifiable Information and Non-Personally Identifiable Information shall be referred to collectively as "Information". By accessing, using or making any attempt to use or access the Website, you agree to be bound by the Terms of Use at [www.Mega-Fabs.com](http://www.Mega-Fabs.com) (the "ToU") and this Privacy Policy. This Privacy Policy constitutes an integral part of the ToU, which shall apply to this Privacy Policy, including, without limitation, the disclaimers and limitations of liability therein and the provisions therein regarding governing law and jurisdiction. This Privacy Policy, as well as the ToU, may be amended from time to time by posting a revised version on the Website, which amendments will become immediately effective.

### 1. Information Collection

1.1 Mega-Fabs may collect Personally Identifiable Information through the Website if you make a decision to fill out a form which provides information to Mega-Fabs on the Website, such as when you register for newsletters, apply for a job or send Mega-Fabs an e-mail through the Website. In such cases, Personally Identifiable Information that might be collected includes, but is not limited to: contact details (name, address, email, telephone number, etc.); professional information such as job title, previous jobs, professional experience and qualifications; and the content of your correspondence with Mega-Fabs.

1.2 You are not under a legal duty to deliver Personally Identifiable Information requested from you on the Website and any such delivery of Personally Identifiable Information is voluntary.

1.3 Personally Identifiable Information gathered by Mega-Fabs is stored in a database. You are advised however that Mega-Fabs is under no obligation to maintain any information, and that you may not rely on the Mega-Fabs's Databases as backup to your operation.

1.4 Mega-Fabs may collect Non-Personally Identifiable Information which may comprise of the following: technical information, including the internet protocol (IP) address used to access the Website, browser type and version, time zone setting, browser plug-in types and versions, operating system and platform, page response times, download errors, length of visits to certain pages, page interaction information (such as scrolling, clicks, and mouse-overs) and methods used to browse away from the page.

1.5 The Website may contain links to third party websites (such as the websites of social networks) that are not owned or controlled by Mega-Fabs (the "External Sites"). You are advised that such External Sites, and any information provided by you on such External Sites, may be subject such External Site's privacy policies, and Mega-Fabs does not control and is not responsible for information provided by you on such External Sites, and/or the conduct or practices of any third party that makes any External Site available.

1.6 In accordance with the Law, you are entitled to inspect, either yourself or through a representative, any Information kept by us, and to demand that Information be corrected or deleted. If you wish to do so, you may submit a request to the Mega-Fabs Contact (as defined below), and Mega-Fabs will treat your request in accordance with the Law.

### 2. Information Use

2.1 Mega-Fabs may use Personally Identifiable Information in order to: (a) contact you upon request, inquiry and/or job application; (b) send you newsletters, updates, notifications regarding events of ours or of others, and similar correspondence related to the marketing activity of Mega-Fabs; (c) provide you with support, respond to your inquiries regarding the Website and/or contact you with respect to claims of infringement of your rights; (d) exercise any right available to Mega-Fabs (by law, agreement or otherwise), including, without limitation, in order to (i) respond to claims made against it; and (ii) to protect against fraud or carry out Mega-Fabs's risk management procedures.

2.2 Mega-Fabs may use Non-Personally Identifiable Information to analyze

Website usage, to help improve the Website quality, design and content, to improve customer service, and to enhance Mega-Fabs's support. You are advised that other uses (not specified herein) may be made with respect to Non-Personally Identifiable Information, that such Non-Personally Identifiable Information may be provided to third parties which are not specified herein, and you hereby waive any claim in this respect.

2.3 Mega-Fabs is the sole owners of all Information collected on the Website.

3. Third Party Disclosure Mega-Fabs does not sell, trade, or otherwise transfer to third parties your Personally Identifiable Information. This does not include disclosure: (a) to Mega-Fabs's employees and/or contractors who need to know such information for the provision of support for the Website and/or services to you or to Mega-Fabs; (b) required in Mega-Fabs view, in order to exercise any right available to it (by law, agreement or otherwise), including, without limitation, in order to (i) respond to claims made against Mega-Fabs; and (ii) to protect against fraud or carry out Mega-Fabs's risk management procedures; (c) in order to comply with legal process, a court order or subpoena or as otherwise required by applicable law; (d) to the extent Mega-Fabs will re-organize its structure (such as by merger), in which case Mega-Fabs may disclose such information to the third party involved, subject to its undertaking to be bound by this Privacy Policy.

4. Cookies

4.1 The Website utilizes cookies to improve your access to the Website and to identify repeat visitors. Most browsers automatically accept cookies, but you may be able to modify your browser settings to decline cookies. Please note that if you decline or delete cookies, some parts of the Website may not work properly.

4.2 Mega-Fabs uses Google Analytics, a web analytics service provided by Google Inc. ("Google"). By using cookies, Google collects and stores certain information. You can prevent the collection of information generated by the cookie regarding your use of the Website by Google as well as the processing of this information by Google by downloading and installing the add-on available under the following link for user's current web browser: <https://tools.google.com/dlpage/gaoptout?hl=en>.
